- Local contact's Singapore Identity Card (original & photocopy); and
- 1 copy of letter from the applicant's employer granting leave of absence and stating how long the applicant has been employed, if any; or
- 1 copy of the household booklet if applicant is a PRC national and is unemployed.

**(C) For Medical Treatment**

- 1 copy of supporting letter furnished by the hospital stating the purpose of visa application and the applicant's medical condition.

**(d) For Cruise passengers in Singapore**

- 1 copy of cruise itinerary in Singapore issued by the travel agent.
